Subject : Revision of various allowances applicable to Principals/Staff members of Sainik Schools.

The matter to enhance the rate of various allowances applicable to Principals/ Staff members of Sainik Schools has been considered and it has been decided with the approval of Hon'ble Raksha Rajya Mantri and Chairman, Board of Governors, Sainik Schools Society to revise the rate of following allowances as indicated below :-

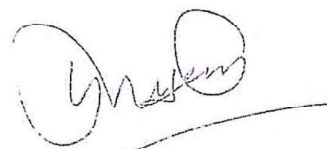
S. No	Name of Allowance	Existing rate (PM)	Revised Rate (PM)	Remarks
1.	Senior Master Allowance.	Rs. 500/-	Rs. 1000/-	As per Rule 5.11(e) of Sainik Schools Society Rules & Regulations, 1997 (SSSR&R). However, the same will not be admissible during the vacation period unless the services of Senior Master is required by the Principal to work during the vacations for more than a month.
2.	P.A. Allowance	Rs. 150/-	Rs. 300/-	As per Rule 5.21 of Sainik Schools Society Rules & Regulations, 1997 (SSSR&R)
3.	Head Allowance to certain categories of General employees.	Rs. 50/-	Rs. 100/-	As per Rule 6.14 of Sainik Schools Society Rules & Regulations, 1997 (SSSR&R)
4.	Allowance for Small Family Norms	As applicable to Central Govt. employees	As per recommendations of VI CPC	As applicable to Central Govt. employees
5.	Cash Handling Allowance	- do -	- do -	- do -
6.	Principals Entertainment allowance	Rs. 500/-	Rs. 1,000/-	As per Rule 11.36 of Sainik Schools Society Rules & Regulations, 1997 (SSSR&R).

7.	Medical Allowance	Rs. 100/-	Rs. 300/-	Policy Letter No. 34(37)/2003/D(SSC) dt. 6.5.2003. It has also been decided that the revised Medical Allowance will also applicable to Pensioners of Sainik Schools. This is as per OM No. 4/25/2008-P&PW(D) of Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Pension & Pensioners Welfare).
8.	TA on official tour	As applicable to Central Govt. employees	As per recommendations of VI CPC	As applicable to Central Govt. employees

2. Principals of all Sainik Schools are requested to note that the expenditure on the above allowances will be met from the internal sources of the schools. They are also requested to ensure that the amount of above mentioned allowances shall not be included in the claim of 80% of additional financial burden arising out of implementation of 6th CPC recommendations forwarded to this office. An undertaking to this effect may be forwarded by the Principal with the claim.

3. These orders shall come into force from the date of issue and there will be no retrospective effect. Past cases which have already been settled will not be re-opened.
